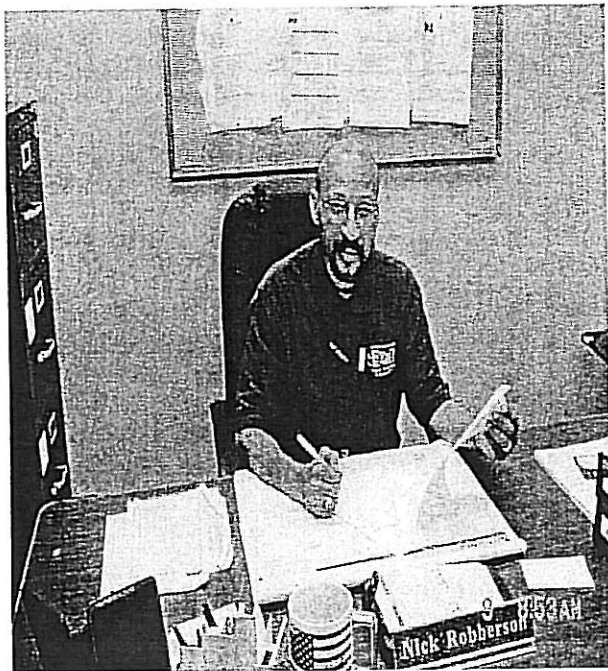

Once your business enrolls in the program, Shreveport Police Department will be able to better assist you in controlling unwanted loitering on your business property. Your signed affidavit will be placed on file for the Shreveport Police Department for **One Year** to reference. Together we can improve the business community of Shreveport!

By signing the affidavit you AGREE:

To appear in court when subpoenaed

To notify SPD of change in ownership

To list any persons authorized to be on your property

To maintain "NO TRESPASSING " signs on your property

Failure to fulfill the above agreement may disqualify you from participation in the program.

Sec. 50-86. Criminal Trespass.

(a) No person shall enter any structure, watercraft, or movable owned by another without express, legal, or implied authorization.

(b) No person shall enter upon immovable property owned by another without express, legal, or implied authorization.

(c) No person shall remain in or upon property, movable or immovable, owned by another without express, legal, or implied authorization.

(d) It shall be an affirmative defense to a prosecution for a violation of subsections (a), (b), (c), of this section, that the accused had express, legal, or implied authority to be in the movable or on the immovable property.

(i) Whoever commits the crime of criminal trespass shall be fined not more than \$500.00, or imprisoned for not more than 60 days, or both.



Your "NO TRESPASSING" sign must state the following:

The dimensions of each sign must be at least 12"x 18" with the letters a minimum of 1" and be of reflective nature to be seen at dark.

SPD requests that the sign be bright neon yellow with black lettering. The bottom of the sign must be at least 4 feet up off the ground.

The sign or signs (multi entrances) must be posted at the entrance to your property reasonably likely to come to the attention of intruders, indicating that trespassing is forbidden.
